Toward a Federation of Library Associations in Canada

In January 2015, the Canadian Library Association's Executive Council initiated a dialogue with colleagues from diverse representative library associations to discuss the future of a unified national voice for Canadian libraries. A working group was struck, and on October 8, 2015, the Future Federation Working Group released the proposal entitled Toward a Federation of Library Associations in Canada: Strengthening the National Voice for Canadian Libraries. The proposal is the result of eight months of discussion and collaboration by a diverse group of representatives from the provincial, territorial and national sector associations brought together to contemplate a new form for our sector's national library association. CALL/ACBD has had representation in the discussions to date.

You are invited to participate in the Survey for Individuals from the working group. Representatives from large library institutions may also want to participate in the Survey for Institutions. The information gathered will be critical for determining any future revisions and next steps. The deadline for both surveys is **Friday, November 13th**.
