## **CFLA-FCAB - Truth and Reconciliation Report Released**

On April 24, 2017, the Canadian Federation of Library Associations' Truth and Reconciliation Committee released a 77-page report, including ten recommendations to "enhance experiences and opportunities for Indigenous peoples and researchers in Canada by decolonizing libraries and archives and their practices." The Committee was created when the Federation was first founded and was chaired by Camille Callison, Indigenous representative on the board of the CFLA-FCAB.

From the news release:

"The report is a first for Canada's library community, using a framework and methodology based on the Anishinaabe medicine wheel. The medicine wheel represents the Four Elements of Nature, the Four Elements of the Human Being, the Four Stages of Life, and the Four Seasons."

CALL/ACBD joined CFLA-FCAB earlier this year. We encourage our committees to review the report now, and take the opportunity in our business meetings at the conference to discuss **how we might best support the recommendations**.
