Though not affiliated with CALL/ACBD, this listserv has played an important communication role over the years for many members. The Board is working with the Association's National Office to roll out a new online discussion forum. We are currently in testing phase and we hope to launch the new platform by late May.

Annual Conference

Our annual conference is just over a month away! A very heartfelt thank you to members of the 2023 CPC for all their hard work in bringing together informative and timely educational programing, inspiring keynote speakers, and a practical pre-conference workshop on leadership. For this year's conference, a couple of traditional programing changes to note regarding the AGM and Open Forum. Although the AGM and Open Form have generally been held during in-person conferences, the Board has decided to hold both of these virtually to ensure greater accessibility and

Vendor Liaison Committee

On March 21, 2023, the VLC met with Allan Akizuki and Steve Assie from Thomson Reuters to discuss the annual VLC survey of TR. TR created [slides](#) that address the survey responses by theme. We appreciate you taking the time to answer the survey and we appreciate Allan and Steve for meeting with us.

While the VLC survey took place before the announcement of the changes to ProView, we asked Allan and Steve to address them, specifically why the decision was made, TR's sometimes confusing communication, the possibility of TTA bundling flexibility, off-line access of TTA titles, and academic access to TTA titles (see slide 13).

After our meeting, Allan sent a [message](#) with more details about the changes. He also included [a list of all looseleaf titles](#) "indicating what is part of TTA, what will soon be part of TTA (in yellow) and what is not part of TTA and will remain available via ProView. While the list does reflect our current position on TTA content we are constantly evaluating our products and collections so this list may be subject to change in the future."

The VLC is currently discussing next steps. While TR has every right to make this business decision, we know that the changes will negatively affect CALL/ACBD members' budgets and collections.
