#### **SCC Intervention**

As you know, CALL/ACBD was granted intervenor status in the case of Keatley Surveying Ltd. v Teranet Inc., 2017

ONCA 748. The hearing was held this past **Friday, March 29**. This case is important to law librarians and the legal profession because it is the first time the Supreme Court of Canada squarely considers s. 12 of the Copyright Act, the section dealing with Crown copyright. Many thanks to our Copyright Committee and especially to Copyright Committee Co-Chair Kim Nayyer, who robed for the hearing.
