Michael Silverstein Prize

About:

The Michael Silverstein Prize has been generously established by Thomson Reuters. This annual monetary award of \$1500 recognizes an outstanding contribution by a member of CALL/ACBD to enhancing understanding, analysis and appreciation of primary law or legal taxonomy. The contribution may be in the form of an article, book, course, research, activities/advocacy or a body of work. The winner will also receive a copy of The Practical Guide to Canadian Legal Research, as Michael wrote the original chapter on the Canadian Abridgment. Michael often spoke of himself as a "primary law guy" and his stewardship of the Abridgment was truly a labour of love.

Nomination process:

- Nominations may come from any member of CALL/ACBD including, but not limited to, a reader or participant of the recommended contribution. Self-nominations are welcome.
- The nomination application should include the name, affiliation and contact information of the nominee and nominating member(s), as well as a letter explaining the reason for the nomination, with reference to the scope of the award. A copy of the article, a course description, the bibliographic citation of the book should be provided where feasible. Supporting documentation such as book reviews or course comments are encouraged.

Selection Process:

The Scholarships and Awards Committee will consider the following when evaluating a nominee:

- Does the work enhance understanding of primary law or legal taxonomy?
- Is the work novel in its delivery or message?
- Who is the intended audience, and does the nominated work seem to meet their needs? Is there documentation to prove that the audience is benefiting from the work (evaluations, reviews)?

The Scholarships and Awards Committee will determine a winner before the early bird registration rate for the conference expires in order to encourage the winner's attendance.
