Canadian Abridgment Editorial Advisory Board – Product Note

The Canadian Abridgment classification system no longer applies only to case law. Thomson Reuters has expanded it to include all areas of Canadian law. One way to take advantage of this extended reach is to find the "Browse Legal Topics" link among the "Finding Tools" on the WestlawNext Canada homepage. The overall taxonomy is the same as in the Abridgment, but there are additional headings.

For example, in Contracts, the Abridgment classification begins with *Part I – Nature of Contract*, and ends with *Part XVII – Statute of Frauds*. Browse Legal Topics includes all of the same, with three additional non-litigation-related topics, ending with *XX – Advertising and Marketing Contracts*.

When you click on a heading you get much more than case law digests. Since Thomson Reuters has classified all of their holdings with the Abridgment taxonomy, in addition to cases you get CED articles, legal memoranda, texts,

annotations, ProView titles, and Practical Law Resources.

The Browse Legal Topics headings can also be searched.

The Canadian Abridgment, for those who don't know, is a comprehensive collection of digests of all reported cases in Canada, originally published by Carswell, and now made available online by Thomson Reuters as a key component of WestlawNext Canada.

The Canadian Abridgment Editorial Advisory Board is always looking for the feedback of CALL/ACBD members on Thomson Reuters' product line.
